

SOUND BEACH CHORAL SOCIETY

A 7.5" X 12 gray notebook was found among the old records of the First Congregational Church. Its cover contains the hand-written title above.

Sound Beach, CT changed its name from Sound Beach back to Old Greenwich in 1932. The Choral Society changed its name at the same time to "Greenwich Choral Society." This is probably the reason why the notebook ended with no further input after 1931.

Many names listed in this document are of some very prominent citizens of Old Greenwich at the time.

Starting with page 1, all hand written is the following:

Nichols retained to secure a President. Plans made for a Community Xmas tree and Carol singing led by Choral Society on Xmas eve in front of Sound Beach School. Mr. Cox and Mr. Howard appointed a committee on arrangements.

Motion made Treas. pay all concert expenses
Motion made Treas. pay Mr. Steele \$150.00
Motion made present flowers to Mrs. Steele at first annual dinner to be held at Sound Beach Golf Club, Wed. June 9 at 7 P.M.
- June 9 Annual dinner, business meeting and election of officers, followed by dancing. Pres. Mr. John Howard presided. Meeting opened with Secretary report for the year, read and accepted. A gift of appreciation presented to Mr. Steele, accepted by him in short speech of encouragement to the chorus, suggesting that rehearsals be resumed the first week in September. Treasurer's report read and accepted. Miss Worrell presented with dressing case in appreciation of her services as accompanist. Motion made and carried to leave decision as to number of concerts with executive comm.
Yearly dues for active members (\$3.00) due Sept. 1st.
Motion made and carried that each member pledge to obtain at least one contributing member at a minimum of \$10.00. per year, each to receive two tickets for each concert, dues payable September 1st.
Motion made and carried that Associate membership be \$5.00 per year, with two tickets for each concert, dues payable Sept. 1st.

Pages 106-120 plus the inside back cover (except pages 116-117) contain pasted newspaper clippings of original concert reviews from June 1925 through June 1931.

**Statement of Purpose and Benefits of Associate
Membership in the Sound Beach Choral Society.**

Quoting the Constitution of our Society, Article #2 states:

"Object"

"The object of this society shall be to advance the interest and promote the culture of music".

On June 2, 1925, under the direction of Mr. Roy Williams Steele, the first concert was given by the Society. Since that time, ten concerts in all have been given, all of which have received very favorable comment.

It is not too much to expect that we will be able to go on to still better work, which will reflect credit not only on the director and the active members, but on the associates, whose community spirit makes them desire to support the choral society in its constructive efforts.

In their preparation for these concerts, the active members feel they receive a very valuable addition to their musical training and that they have helped to further the object of the Society.

It has been felt, however, that the patrons and associate members have not been brought close enough to the active work of the Society, to really feel the interest that their association warrants; neither have they been able to obtain the benefits that their association should afford.

This condition we are now trying to eliminate, and propose.

1st. That all patrons and associate members be invited to a general meeting to be held about two weeks before each concert, at which time plans for the success of the coming concert will be discussed, and also the matter of making it more surely a permanent figure in the cultural life of our community. After the business meeting an interesting talk will be given by a well known music critic on the numbers to be given at the concert.

2nd. That all patrons and associate members be invited to all social affairs of the society, including an annual social gathering, the first of which is to be given late in January or early in February, 1931.

3rd. That each patron and associate shall received two admissions to each concert.

4th. The dues for associate membership to be \$5.00 per year.
